# MOTION TO APPROVE TRANSACTION WITH MYMICHIGAN July 13, 2023

#### Commissioner Savoie moved, seconded by Commissioner Lieurance, to approve the following:

- 1. Resolution 2023-17, Approving the Transfer and Sale of Hospital Facilities To MyMichigan Medical Center Sault, with Continuing Commitments and Promises of MyMichigan Health, subject to the following:
  - The Agreement of Purchase and Sale, Joint Escrow Instructions, and Continuing Commitments and Promises, which provides the terms of sale of County-owned hospital facilities to MyMichigan Health and MyMichigan Medical Center Sault, will be amended to permit the County of Chippewa to review the title report and commitment prior to closing, and if the County determines in its discretion that the condition of title is such that County would be exposed to unreasonable liability the sale is closed, the County may give written notice to MyMichigan Health and MyMichigan Sault that the County will close the sale only if MyMichigan Sault agrees to waive the adverse condition of title, and MyMichigan Health commits to fully assume the liability determined by the County to exist, and such action by the County shall not be considered to be a breach under the Agreement; and
  - The Chair of the Chippewa County Board of Commissioners is authorized to execute the Agreement, as amended, on behalf of Chippewa County; and
  - The Chippewa County Administrator is authorized to proceed with a closing with MyMichigan Sault and MyMichigan Health according to the terms of the Agreement, as amended; and also
  - The Chair of the Chippewa County Board of Commissioners; or in the alternative by the Chippewa County Clerk and the Chippewa County Administrator, are authorized to execute the closing documentation prepared in accordance with the approved Agreement, as amended.
- 2. To facilitate the mutual interest expressed in the Agreement of Purchase and Sale for the continuation of indigent care to Chippewa County residents and visitors, the Chippewa County Administrator is authorized to execute the appropriate agreement with MyMichigan Medical Center Sault to continue the existing indigent care services with MyMichigan Medical Center Sault to ensure that the facility meets all applicable local, state, and federal laws and regulations, with no new obligations of the County.

A discussion took place before a roll call vote was taken, some of the comments are listed below:

• Commissioner Savoie stated that MyMichigan has been very, very good to work with throughout negotiations. He also noted that he did not receive any opposition to approving the transfer of hospital facilities to MyMichigan Medical Center from his constituents as long as it is sold at fair market value.

- Commissioner Shackleton communicated that he was Chairman of the Hospital Board for many years. During that time, the hospital investigated whether they should stay independent or find a partner to go forward with. After much time researching what would give the best health care for our community in the future, the Board, together with Administration, concluded that they needed a strong partner. They interviewed and investigated several potential partners and found MyMichigan to be the closest to the type of culture/approach to our community they were already doing in other communities as we do here.
- Commissioner Traynor noted that in his research MyMichigan has upheld everything it promised in Alpena.
- Commissioner Lieurance noted that his basic philosophy is that government should own as little as possible, owning this land will not help us and that they negotiated in good faith. He feels very comfortable going through with this transaction.
- Chairman Martin noted that he continued to not understand the necessity of the transfer at this time. Still, after discussing with Dr. Watson, he hopes that everything does happen as it has been presented to him and that they (MyMichigan) prove him wrong.

# RESOLUTION APPROVING THE TRANSFER AND SALE OF HOSPITAL FACILITIES TO MYMICHIGAN MEDICAL CENTER SAULT, WITH CONTINUING COMMITMENTS AND PROMISES OF MYMICHIGAN HEALTH

#### #2023-17

WHEREAS, Chippewa County, through its Board of Commissioners ("Board") is the owner of certain Hospital Facilities located at 500 Osborn Boulevard, Sault Ste. Marie, MI 49783, historically referred to as the Chippewa County War Memorial Hospital Facilities ("Hospital Facilities"). These Hospital Facilities are currently leased to MyMichigan Medical Center Sault ("MyMichigan Sault") until December 31, 2081 for purposes of providing health care services in Chippewa County under a lease which was last updated in 2021; and

WHEREAS, MyMichigan Sault and MyMichigan Health, a non-profit corporation and Sole Member of the seven hospital subsidiary medical center network in Michigan ("MyMichigan Health"), represented to the Board of Commissioners that there was a desires to make extensive improvements to the Hospital Facilities, and that it would facilitate financing and the allocation of moneys for such purposes if ownership of the Hospital Facilities were sold to MyMichigan Sault and MyMichigan Health, with the deed of conveyance transferring title from the County to MyMichigan Sault; and

WHEREAS, to induce the Board to proceed with such sale and transfer of the Hospital Facilities, MyMichigan Health and MyMichigan Sault have offered to pay to the County, in cash, the amount of \$2,000,000.00 for such sale and transfer, and have also committed to complete \$70,000,000.00 of improvements to the Hospital Facilities during the ten-year period commencing January 1, 2022 and ending on December 31, 2031. MyMichigan Health has also proposed that, acting with MyMichigan Sault, it would carry out certain related actions which will further maintain and enhance health care services in the County for such ten-year period, and will secure such actions by consenting to incur liability for

damages if such actions are not fulfilled, as detailed in the "Formal Agreement" described in this Resolution; and

WHEREAS, at a public meeting on June 13, 2023, the Board adopted Resolution 2023-11 tentatively approving a Conceptual Understanding for Hospital Transfer Agreement ("Conceptual Understanding") which embodies the terms and conditions for a deed of conveyance transferring the Hospital Facilities from the County to MyMichigan Sault, including the specification that MyMichigan Health will carry out its offers, commitments and promised actions in exchange for such transfer. The Board clarified in the June 13, 2023 Resolution that the tentative approval of the Conceptual Agreement is subject to further deliberation by the Board as a condition to finally approving an agreement incorporating the Conceptual Understanding, and that such final approval would not occur until after the Board has provided the opportunity for the public to provide comments and input on the Conceptual Understanding at the Board's open meeting on July 13, 2023; and

WHEREAS, the public has had 30 days in which to review the Conceptual Understanding, and the opportunity at the open meeting of this date to provide comment and input to the Board, and the Board has received and considered such public comment and input, and has determined that it would be in the public interest to approve the sale and transfer of the Hospital Facilities based on the offered consideration and other terms contained in the Conceptual Understanding; and

WHEREAS, consistent with the direction given in its Resolution adopted on June 13, 2023, special legal counsel for the County has worked with representatives of MyMichigan Health to formulate a proposed agreement reflecting the terms of the Conceptual Understanding with sufficient detail and precision to be binding on and enforceable by the parties, and to carry out the intent of the Conceptual Understanding. A proposed agreement to this effect has been prepared, entitled Agreement Approving the Conveyance Transferring Title of Hospital Facilities to MyMichigan Sault, with Continuing Commitments and Promises of MyMichigan Health ("Formal Agreement").

**NOW, THEREFORE, BE IT RESOLVED** that the Chippewa County Board of Commissioners approves the Formal Agreement"), as presented to the Board; and

**BE IT FURTHER RESOLVED** that the Chair of the Chippewa County Board of Commissioners is authorized to execute the Formal Agreement on behalf of Chippewa County, and the Chippewa County Administrator is authorized to proceed with a closing with MyMichigan Sault and MyMichigan Health according to the terms of the Formal Agreement; and

**BE IT FURTHER RESOLVED** that the Board authorizes any and all closing documentation prepared in accordance with the approved Formal Agreement to be executed by the Chair of the Chippewa County Board of Commissioners; or in the alternative by the Chippewa County Clerk and the Chippewa County Administrator.

# <u>Health Department - Agreement for General Inpatient Care and Respite Care for Hospice</u> <u>Patients - updated to reflect MyMichigan Health</u>

The Committee reviewed the updated Agreement between the Chippewa County Health Department (d/b/a EUP Home Health and Hospice) and MyMichigan Medical Center Sault that the Agency and Provider provide hospice services to those in patient at MyMichigan Medical Center Sault. For clarification, the Indigent Care and 340B Health Care Services Agreement will be addressed with Resolution 2023-17.

It was moved by Commissioner Savoie, seconded by Commissioner Traynor, to approve the Agreement for General Inpatient Care and Respite Care for Hospice Patients between the Agency Chippewa County Health Department (d/b/a EUP Home Health and Hospice) and MyMichigan Medical Center Sault as the Provider as presented to reflect MyMichigan Health. On a voice vote, the motion carried.

# <u>Health Department – Albert Heating and Cooling quote for A/C Unit \$4,730 in IT office</u> w/Cloverland \$1,500 rebate (Net cost \$3,230)

The Committee reviewed the Albert Heating and Cooling, Inc. quote and purchase order request to replace the HVAC system in the Information Technology Office, a cost of \$4,730.00 with a Cloverland rebate of \$1,500.00.

<u>Child Care Fund – Probate Court – Amended County Child Care Budget Summary (DHS-2091)</u> The Committee reviewed the amended County Child Care Budget Summary (DHS-2091), which increased the basic grant category from \$15,000.00 to \$56,520.00.

#### Office of Emergency Services - Medical First Responder Training \$7,335.00 for 10 people

The Committee reviewed a request from Director Postma to fund training for ten (10) attendees to attend the Medical First Responder course from Office of Emergency Services funding.

# <u>Office of Emergency Services – FY2022-23 Hazardous Materials Emergency Preparedness</u> (HMEP)

The Committee reviewed the request to approve and authorize the documents and materials for the FY2022-2023 HMEP Hazardous Materials Emergency Preparedness Grant, which includes the grant agreement, sub-recipient risk assessment certification, certifications regarding lobbying, standard assurances, audit certification (EMD-053) and request for taxpayer ID.

It was moved by Commissioner Savoie, seconded by Commissioner Traynor, to approve and accept the FY2022-2023 Hazardous Materials Emergency Preparedness Grant (HMEP) and to authorize the necessary documents. On a voice vote, the motion carried.

<u>Sheriff's Department – Stonegarden Purchases – License Plate Reader (2<sup>nd</sup> Phase) \$104,985.00</u> The Committee previously authorized and approved a Stonegarden purchase for a License Plate Reader system for Chippewa County; the Sheriff's Department is ready for Phase Two (final phase), which will install the cameras at the Chippewa County ferry docks utilizing Stonegarden monies of \$104,985.00

It was moved by Commissioner Savoie, seconded by Commissioner Lieurance, to authorize utilizing Stonegarden funding of \$104,985.00 to purchase additional License Plate Reader systems to be installed at the ferry docks. On a voice vote, the motion carried.

#### Administration - MEDC CDBG Annual Reporting

The Committee reviewed the annual Program Income Certification for the CDBG-MEDC Form 8-H; from 7/1/2022 to 6/30/2023 – the County received \$0.00 in early payoffs from prior Community Home

Improvement Loans. If the funds were below \$35,000, they could be transferred back to the GF; if they were over \$35,000, the funds would be returned to the MEDC.

It was moved by Commissioner Savoie, seconded to Commissioner Lieurance, acknowledged, and accepted the Program Income Certification from 7/1/2022 to 6/30/2023 and the Single Audit Certification. On a voice vote, the motion carried.

It was moved by Commissioner Savoie, seconded by Commissioner Shackleton, to approve the Administration travel request to Escanaba for MMRMA-offered training on October 20, 2023. On a voice vote, the motion carried.

Administration - USDA/Forest Service - Secure Rural School - Election to receive payment
The Committee reviewed the FY2023 Forest Service payments to States, Public Law 117-58, which
2023 will be the first year in ten years since the counties will have the option to change our payment
election between the Secure Rural School and 1908 Act; the County is currently splitting the payment
80% Title I, 13% Title II and 7% Title III. The Departments requested no change.

It was moved by Commissioner Savoie, seconded by Commissioner Lieurance, to approve, and authorize the Secure Rural School election to remain the same at 80% Title I, 13% Title II, and 7% Title III for the State payments. On a voice vote, the motion carried.

#### Finance - Claims and Accounts - June - County and Health Department

It was moved by Commissioner Savoie, seconded by Commissioner Shackleton, to recommend the approval of June County bills and payroll: general claims of \$385,527.21, other fund claims of \$1,057,785.13, payroll of \$794,299.52, and Health Department claims \$305,040.67 and payroll \$397,809.83 total claims \$2,940,462.36. On a voice vote, the motion carried.

It was moved by Commissioner Savoie, seconded by Commissioner Lieurance, to accept July 11, 2023, Finance, Claims, and Accounts Committee Meeting Minutes as presented. On a voice vote, the motion carried.

# COMMISSIONER REPORT ON MEETINGS AS BOARD REPRESENTATIVE AND GENERAL COMMENTS
