Approval of the Agenda

It was moved by Commissioner Martin, supported by Commissioner Traynor, to approve the agenda as presented. On a voice vote, the motion CARRIED.

Correspondence and Informational Items

The Committee reviewed the Treasurer's report, the VISA billing, travel requests, Home Health and Hospice report, the DTRF-MERS Quarterly reports and statements and the MAC-Chippewa County review. No action required.

<u>AGENDA ITEMS</u> <u>Register of Deeds - Change</u> <u>Kofile to US Imaging (additional \$2,815.18 – Fund 256)</u>

The Committee reviewed a letter from Register of Deed Gigi Ferro; regarding the recently approved scanning project with Kofile; as the quote originally presented was an error on the vendor; which they would not honor the pricing. New accurate pricing was sought from US Imaging (HFGroup) in the amount of \$9,172.00; as additional \$2,815.18 to complete the job utilizing Special Fund 256 monies, with a 12-week timeframe to complete the job.

It was moved by Commissioner Lieurance, supported by Commissioner Traynor, to approve and authorize the additional \$2,815.18 for a total of \$9,172.00 to complete imaging with US Imaging for 1334 pages. On a voice vote, the motion CARRIED.

<u>Administration – Change Short-term, long-term, life and voluntary life carrier per quotes from 44North</u> <u>– switch to The Hartford</u>

The Committee reviewed the comparable rates between our current carrier Lincoln Financial Group and The Hartford; with The Hartford showing an estimated annual savings of \$3,660.00 for the employee benefits. 44North sought the quotes on behalf of the County. The voluntary life insurance is 100% employee paid; the other are employer paid.

It was moved by Commissioner Martin, supported by Commissioner Lieurance, to accept and authorize the quote from The Hartford for the employees short and long term, life and voluntary life insurances, as presented. On a voice vote, the motion CARRIED.
